1 A BILL for an Act to amend and reenact section 37-14-14 of the North Dakota Century Code,
2 relating to the veterans' postwar trust fund; and to provide for an appropriation to the
3 department of veterans' affairs and for a transfer from the department of veterans' affairs.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 37-14-14 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **37-14-14. Veterans' postwar trust fund.**

8 The veterans' postwar trust fund is a permanent trust fund of the state of North Dakota and
9 consists of moneys transferred or credited to the fund, ~~pursuant to~~ under this chapter and other
10 laws. Investment of the fund is the responsibility of the state treasurer who shall invest the fund
11 only in those legal investments authorized by section 21-10-07. All income received from
12 investments is to be utilized only for programs of benefit and service to veterans or their
13 dependents, and all income earned in a biennium is appropriated to the administrative
14 committee on veterans' affairs on a continuing basis in the following biennium and not in the
15 biennium the income is earned for expenditure on these programs as authorized by law.

16 **SECTION 2. APPROPRIATION - TRANSFER - DEPARTMENT OF VETERANS' AFFAIRS.**

17 There is appropriated out of any moneys in the general fund in the state treasury, not otherwise
18 appropriated, the sum of \$210,000, or so much of the sum as may be necessary, to the
19 department of veterans' affairs to be used in lieu of income generated from the veterans'
20 postwar trust fund for programs authorized by law to benefit and serve veterans or their
21 dependents, for the biennium beginning July 1, 2011, and ending June 30, 2013. The income
22 generated by the veterans' postwar trust fund during the biennium beginning July 1, 2011, and
23 ending June 30, 2013, must be held with the corpus of the fund for appropriation to the

1 department of veterans' affairs as income for the biennium beginning July 1, 2013, and ending
2 June 30, 2015.

3 **SECTION 3. APPROPRIATION.** There is appropriated out of any moneys in the general
4 fund in the state treasury, not otherwise appropriated, the sum of \$50,000, or so much of the
5 sum as may be necessary, to the department of veterans' affairs for the purpose of purchasing
6 vans for the transport of veterans or their dependents, for the biennium beginning July 1, 2011,
7 and ending June 30, 2013.
