Minutes

December 1st, 2022
1300 PM

Meeting was called to order at 1300 pm; we opened with the Pledge of Allegiance.

Roll Call was conducted and showed representation from all 5 Veteran Service Organizations. All members were present except Matt Herrud and Bobby Beauchamp from the DAV and Tom Turk from the VFW.

Minutes from the September 8<sup>th</sup> ZOOM meeting were presented. Motion was made by Dan Stenvold from the VVA to approve the minutes, seconded by Kenny Wiederholt from the American Legion....Motion Carried.

Bill Tuff then reported the NDVLC had \$7,687.90 in our checking account. Invoices from Flash printing for ne brochures and cards for the legislative session were paid. He noted that 4 of the 5 VSO's have paid their dues. The American Legion will have it paid before the end of December. Larry Young from the VVA made motion to approve the treasurer's report, seconded by Russ Stablier from the VVA, motion carried.

**OLD BUSINESS** the new NDVLC Brochure was shown, every group got some for their organization. Jim reported that one is also being given to each legislator before session begins.

The 2023 dues were covered in the Treasurer's report.

#### **NEW BUSINESS**

First, Corey Moen from the VFW just brought to everyone's attention that to get any hunting tags like deer or elk to raffle off from Game and Fish the current law states you must be a 501 C3 Non-profit and there may be people looking to open that up to other non-profits like VSO's which most are a 501 C4. He just wanted us to be aware and everyone agreed we would support this change if we saw a bill about this issue.

We then discussed the importance of those testifying to be registered lobbyists when we testify. A motion was made my Corey Moen, VFW to have the NDVLC pay the \$25 fee to get registered, seconded by Vern Dunnick, AMVETS; motion carried. Once we register, we are to present a receipt to Treasurer Bill Tuff and he will reimburse us the fee.

We then began to finalize 2023 Legislative Items that were presented to us from Commissioner Lonnie Wangen.

# 1. Appreciation of Veterans and Military

We voted to support with the changes, taking out DAV plate and not creating a new plate. Focusing on removing "un-remarried" and purchase of "vanity or specialty plate.

a. (HB 0001) Vehicle Plates

**Representative Cindy Schreiber-Beck** 

Intent of legislative bill:

Allow any surviving spouse in receipt of VA dependency and indemnity compensation (DIC) to be eligible to purchase a "Vanity" or "Specialty" plate.

- 1. NDCC 39-04-18
- i. Law currently allows a veteran to "display either a distinctive license plate or a standard plate that does not identify the veteran as a veteran or disabled veteran which is issued by the department"
- ii. (remove "Un-remarried" from law)
  - Would match Federal VA DIC eligibility. Simplify the law so if VA determines eligibility for DIC-then qualify for ND military or patriotic plate.
  - 2. NDCC 39-04-18
- iii. Minimal fiscal note expected

- i. Pro-rated for part-time students (45 months or 10 Semesters)
  - 1. Example: ½ time status uses only ½ month or semester
  - 2. Currently even 1 class in a month=full month utilized
  - 3. Reason: Difficult for surviving spouse to go to school full time, work and take care of children.
- ii. Used for bachelor's or master's etc.
  - 1. Allow 45 months or 10 Semesters for any educational goal
    - a. Due to highbred classes
    - b. If taking more than 12 credit hours and finish early-can continue towards masters etc.
- iii. NDCC 15-10-18.2 and 15-10-18.3

Intent of legislative bill: Voted not to include with first part Do not support this session

    - a. Amend DD214 requirement to allow a certification that the individual is expected to be discharged or released from active duty in the uniformed services under other than "dishonorable" conditions not later than 120 days after the date of the submission of the certification.

  - 1. All current or prior members in good standing
- iii. NDCC 37-19.1
