## New Subcommittee Assignments.

The agenda of the meeting will change with the Speakers and the Commissioner's report heard on the first day then the committee breaking into subcommittees.

The subcommittees will choose their chairman when they meet. Chairman Overby reviewed the Century Code regarding the Administrative Committee. The work of the

Committee is for all veterans in the State, not just the organizations that members were chosen to represent or for personal agendas. This is a legislative year so we will be working on legislation to help the Department of Veterans Affairs, the Veterans Home and the veterans of North Dakota. The only way we can do that is to work together.

Mike Fisher asked if the full committee had to approve the changes made. Chairman Overby responded that the only subcommittee named in the Century Code is the Department of Veterans Affairs. All other subcommittees are at the Chairman's discretion.

► Discharge Project – discharges from 8/1/1990 to present have been scanned into database.

- ► Loan Program 190 current loans, available balance \$140,471.26
- ► Strategic plan updated thru September 2012

Jim Verwey asked about the Loan Program and if there were many delinquent loans. Commissioner Wangen stated there are not many bad loans but the fund could use an influx of money. Richard Belling asked about the Fisher House situation. Fifteen million will be needed to fix up the Cardinal Muench seminary to use for rehabilitation for veterans.

Other information presented by the Commissioner included:

- The vans that go to Minneapolis are run by the DAV and VA.
- Upward Bound put in for a grant and found out they were not approved. It was a five year grant and they are in their fifth year so legislation may be submitted for the State to cover the cost of this program. It may turn out to be a good thing to turn it into a state program.

► Suicide prevention and resiliency within the military is being pushed very hard. Army Nat'l Guard will stand down for one full day during training in October to address the issue.

# Legislative Initiatives

► Requesting additional funding for the Bonus, which is based on the number of months of service.

► Tuition enlistment compensation package - asking for additional funding on top of regular funding. FY 2013 on the federal side should be okay, it's FY2014 that is causing funding concern.

► Requesting FTE's – Outreach Officers in the Military Service Centers are temporary workers and the Guard wants to make them permanent employees

► Requesting funding to institute a program that would recognize retiring National Guard members by giving them a flag

▶ Would like to institute an outreach program for Gold Star families

Enable motorcycle riders to get a military motorcycle license plate

► State Active Duty Enhancement Package – so those that are called to state active duty don't suffer from financial hardships due to incidental costs. i.e. gaps in medical coverage.

# Susan Gunsch, Job Service North Dakota

SkillBuildND North Dakota is a \$2 million grant that targets Native Americans and veterans to give them the skills necessary for jobs in oil fields, truck driving, HVAC and other building trades. Funding was received in July and they are trying to get the word out about the program. [HANDOUT]

## Peggy Wheelden, Public Affairs Officer, VA Medical Center

- ► Lots of construction is still underway at the facility.
- ▶ Budget for FY2013 is sufficient; they are starting to work on FY2014 budget.
- ► Caregiver Support Program the caregiver can receive a stipend to care for a veteran
- Awarded a contract of \$8.4 million for more outpatient treatment space
- ► Stand Downs scheduled: Minot Oct 18<sup>th</sup>, Fargo Oct 25<sup>th</sup>, Grand Forks Nov 15<sup>th</sup>

► Veterans can go to the CBOC in Bismarck and get photo ids instead of coming to Fargo

▶ Progressing with the Devils Lake CBOC; it usually takes about a year to put it in place.

► Native American Outreach scheduled at Belcourt on October 16 & 17. All veterans are encouraged to attend.

- ▶ Women's Health and Wellness Program schedule for October 16<sup>th</sup>.
- ► Flu shots are available.

# Mark Johnson, ND Veterans Home Administrator

► The Gazebo has been moved and the concrete is finished around that area

► Occupancy rate is 52 for the skilled side, and 81 for the basic side.

▶ 2013 - 2015 submitted the basic budget is at \$21.1 million. The optional package contains funding for the demolition of the former building and a steel building to house items from the former building.

► Melvin Norgard fund is starting to receive more oil revenue

► The National Guard has been contacted for assistance with some projects such as removing tree stumps from various areas of the grounds and the possibility of putting in a bridge.

Administrator asked about the status of replacing his home on the Veterans Home grounds. There has been discussion of bringing in another home but it shouldn't be the Veterans Home doing it, it should come from another source according to Office of Management and Budget. It may have to wait for another session unless the ACOVA and/or ND Veterans Coordinating Council want to put it forward in a legislative bill.

# Laura Bearfield, Attorney General's Office

Ms. Bearfield introduced Dave Schaibley who will be our new attorney from the Attorney General's Office. He is a Desert Storm veteran and is moving here from Minneapolis. Mr. Schaibley is originally from Bismarck ND.

## Subcommittee reports

**Veterans Affairs & Budget** – Dave Hilleren, Chairman Minutes from previous meeting accepted. Dave Hilleren elected chairman, Richard Belling elected Vice-Chairman and Carroll Quam elected Secretary. Mission statement ACOVA Meeting September 27, 2012 Page 8 of 10

adopted: "To provide insight and oversight to the Commissioner and the Department of Veterans Affairs." Subcommittee recommends the establishment of a "small money" grant fund of \$1,000 a month not to exceed \$12,000 a year. The fund will be disbursed at the discretion of the Commissioner. This would cover small incidentals that come up and are not covered by other sources. The trial period would be 10 Oct 2012 thru 30 Sept 2013 based on the Attorney General's Office approval. Reviewed the 2013-2015 Budget and the expenditures as of June 30, 2012 and accepted the reports. Strategic plan reviewed with no changes planned. Commissioner's evaluation was completed.

# Motion by Ron Otto to approve the small money grant fund as outlined in the committee minutes, second by Mike Fisher. Motion carried.

Motion by Carroll Quam to approve the minutes as submitted by Carroll Quam, second by Ken Hasby. Motion carried.

# PWTF & Appeals – Trish Hodny

Trish Hodny elected chairman. The subcommittee decided to keep the committee meetings separate and hold the PWTF meeting followed by the Appeals meeting.

PWTF subcommittee met. Mission statement adopted, "The committee reviews and makes recommendations to the full committee on requests from entities wishing to use the postwar trust fund interest earnings for projects benefitting North Dakota veterans and their dependents."

There was discussion and a recommendation by the committee to have a Commissioner's discretionary fund in the amount of \$12,000 a year, \$1,000 a month limit starting October 1, 2012. This is contingent on the Attorney General's Office ruling. Meeting adjourned.

Appeals subcommittee meeting held. The committee adopted a draft mission statement, "To hear appeals of the department's decisions on its financial assistance programs taking into consideration the North Dakota Century Code and the ACOVA Policies and Procedures." Meeting adjourned.

# Motion by Carroll Quam to authorize a discretionary fund of \$1,000 a month, \$12,000 a year out of the PWTF general fund allocation contingent on the Attorney General's Office, second by Jim Verwey. Motion passed.

Motion by Ken Hasby to accept the two subcommittee reports, second by John Hanson. Motion passed.

Legislative Subcommittee – John Hanson

Lee Finstad elected chairman. Lee was contacted by telephone. Mission statement adopted, "To present, advocate and support legislation that is advantageous to all veterans, especially disabled veterans." Current proposed legislation discussed.

## Motion by Jim Verwey to approve report, second by Richard Belling. Motion passed.

Chairman Overby asked John Hanson to address the changes the ND Veterans Coordinating Council made to Bills #3 and #17.

Bill #3 – Legislators will be tasked to give some type of property tax relief. The Council voted to strike the \$5,400 stated in the bill. *Motion by Trish Hodny to accept the amended version of Bill #3, second by Carroll Quam. Motion carried.* 

Bill #17 – The Council voted to include hunting. Motion by Carroll Quam to accept the amended version of Bill #17, second by Trish Hodny. Motion carried.

Chairman Overby thanked the subcommittees for their hard work. He dropped in on the subcommittee meetings and noted everyone was working on mission statements and there was a lot of good discussion. He stated the need for everybody's support on the legislative issues. "We go up to the Legislature as one voice, united with the Coordinating Council and other veterans, these bills will get passed. Legislation works better if everyone works as one."

Discussion on the next meeting date, sometime in November. The format of the meeting will change with the full committee meeting on Thursday afternoon. Speakers will come in on Thursday and the Commissioner will give his report that afternoon also.

Mike Fisher asked that the Freedom Riders and other veterans' motorcycle groups be put on call for legislative meetings. They have quite a presence at the Legislature.

## Public Relations Subcommittee – John Adolf, Chairman

John Adolf elected chairman. Mission statement adopted, "Promote awareness and issues of ACOVA to disseminate information of veterans issues to the media and to the veterans organizations and auxiliaries." Motion on investigating the cost of putting notices in county newspapers.
