VA Health Care Services Director: Lavonne Liversage

- ➤ Staffing money used to ramp up care providers \$50,000,000,000 for veterans outside 40 miles of a VA facility to use Health net and their veteran's health card. Veterans should be receiving their cards now. Third party administrator in ND does not have that strong of a network in ND as of yet.
- > Secretary McDonald working on his plan to improve service to Veterans at the VA.
- ➤ Major objectives in VISN 23: is to treat Hep. C., missed opportunities (no show rates).
- ➤ Having town hall meetings every quarter. Next one in Detroit Lakes Feb 26, 2015. Evening meetings have had more attendance. Minot is planned for a town hall also.
- ➤ Budget: at the highest point we have 982 now and hiring another 22.
- Military Sexual trauma group sessions for males is starting.
- > Tele-chaplain services are starting.
- ➤ Social work-now have Hud-Vash workers in Dickinson and Williston. New shelters in Williston "Project eat" is one of them also Guardian Foundation-both strictly for males.
- ➤ Veterans Medical Foster home: in its infancy stage, where veterans can continue to live in foster family homes.
- ➤ Home-based primary care brochures handed out.

- ➤ Construction- a lot of work. Labs, rooms for care. Bids for our emergency room entry. ICU will be renovated also.
- ➤ CBOCS: have 10 now. Just opened in Devils Lake last year. Now have another manager. Leases up in Dickinson, Bismarck, Minot and Williston.
- Minot Security-Airforce Base: issues with veterans having to stop at visitors center. Looking at having a one year visitors card to help with the timeliness.
- ➤ El Paso Texas shooting of VA employee at the CBOC on base.

Ken Hasby asked about the healing garden.

-Starting phase one this summer.

Trish Hodney had question about Obamacare subsidized program and the VA- are there issue or complaints that you may have received?

-Have not had any complaints to my office. They can opt out of VA care.

ND Veterans Home: Mark Johnson, Administrator

- > Spoke about budget that will be presented to appropriations tomorrow and passed around photo of bridge concept.
- ➤ 3 grants applied for to help pay for the bridge with DOT, Outdoor heritage fund and state general funds.
- ➤ Workshop is funded in governor's budget using the Melvin Norgard fund and special funds we have.
- Administrator's house: Governing board is asking for the house to be funded and built. 4,000 square foot handicapped accessible home is planned. To be built on campus. Building a home in Lisbon is not fiscally sound investment and homes are not available for purchase.

ND National Guard: General Dohrmann

- ➤ 40 troops returned from Afghanistan. Security police from Minot AFB relieved. And Kosovo troops returned. 38 soldiers deployed to the SW border-aviation patrol.
- ➤ Legislation:
- ➤ HB 1104 updates civil relief act to match federal. Updates the retirement ages allowing some to serve past 60 years of age. Continues adjustment compensation (War Bonus).
- ➤ HB 1105 Criminal history background checks on anyone dealing with victims of MST, Children etc.
- ➤ HB 1106 Veterans Court bill. Designed to ensure that prior to sentencing the judge will inquire into whether the person served in the military. Consider treatment rather than incarceration. Partnership with NDDVA and ND Human Services. Initiative by chief of supreme court may also be introduced-similar to drug court.
- ➤ Additional Full time equivalent for Military Service centers

- > Traumatic Brain injury bills: we are keeping an eye on those also. Some initiatives we did not put in that will affect veterans. Exempt retiree pay from state tax, vehicle license plate fees.
- ➤ HB 1208 Honorary veteran status for person served 6 years in the National Guard. No benefits provided just the status.
- ➤ Veterans Cemetery: Last year there was a bill to provide caskets. Looking at waiving the fee for burial of spouses, state would pay this portion. About \$160,000 fiscal note.

Committee Reports:

Postwar Trust Fund Subcommittee: Myron Langehaug reported.

Discussed ways to raise funds. No requests for funds to review.

Motion to accept report by Carroll Quam Second by Ken Hasby Motion passed.

Legislative Subcommittee: Dave Hilleren reported.

- > Discussed the "Un-remarried surviving spouse" bill and reviewed the bills being submitted by National Guard.
- > Discussed questions for state treasurer.

Motion to accept report made by Ken Hasby motion second by Ron Otto Motion passed.

Department of Veterans Affairs & Budget Subcommittee: Trish Hodny reported.

- ➤ Discussion of last meeting on NDCC and ACOVA bylaws and constitution and the commissioners completing packet of all laws and policies.
- Discussed Strategic plan will review and update next meeting.
- ➤ Discussed the Vetra Spec alleged breach of information. There is no evidence that anyone has accessed anything without authority. This is in the hands of the Attorney General's office and Commissioner.
