Discussion was held on creating a strategic plan for the NDVCC, this will take place and more work will be done on it prior to the next meeting.

The new National Veterans Cemetery name we have to have our ideas in by 30 November

The Accreditation report was given on how and who gives proper accreditation of our VSO and NSO .

We discussed the way that formal recognition was formed and what we would have to do legislatively to clear up the mess.

DAV VANS- no need for new van in 2018 mileage doesn't justify a replacement in 2018 Lonnie has paper justification from the VA

CVSO: letters from organizations to show that we work together for veterans – not those 2 or 3 individuals who expose their own beliefs. We need to show a united Front to show that we are unified in our support of Veterans Issues. DO NOT AIR DIRTY LAUNDRY IN PUBLIC DO IT IN PRIVATE.

Bruce Sailer asked if Governor Burgam understands what the NDVCC and the ACOVA stand for and what they do. The Governor's Veterans Coordinator met with Lonnie and was shown what we do.

Utilization of Funeral coins Cost & Charges logistics and distributions

Trish Hodney brought up idea about a new idea for the CVSO hire as a state employee Dept of Veteran Affairs, take out of the hand of the county commissioners keep all current CVSO until they retire and then run them through the state.

County Commissioners don't fully understand all of the requirements of the cvso , ask for a study and plant the seed ; push for 2020.

Also have an attorney on staff to do appeals- difficult procedure must have broad education for appeals claims. Second opinion on appeals bad advice of some cvso's. Possible attorney from the attorney generals office a part of the state Veterans process.

There have been models built from different organizations how to use and distribute the cvso's for the state ie: who championed the child enforcement model and pushed it forward.

Can we do this in the 2019 legislative session

Specialization of claims do away with competition VFW/Legion/DAV all would work on different segments of the process

Dave Rice: Change of the Century Code NAVSCO do away with the Law or change it TRISH change it to any fully accredited VSO/NSO system ie VFW/LEGION/Amvets/DAV Standardization and uniformity.
