OLDER GI BILLS

- ► Chapter 30-Montgomery GI Bill Active Duty
 - ▶ Most service members elect Chpt. 33
- Chapter 32 Post-Vietnam Veterans'
 Educational Assistance Program (VEAP)
 - ▶ Most service members do not qualify
- ► Chapter 1607 Reserve Educational Assistance Program (REAP)
 - ▶ No new applicants
 - ▶ Sunset is November 25, 2019

POST 9/11 GI BILL

- ▶ Also called chapter 33 or "Forever GI Bill"
- ▶ 36 Months of benefits
- Pays Tuition, fees, books and supplies
- ► Pays a monthly housing allowance (BAH) based off where the student is attending the majority of their classes
- ► Amount of payment is based on the months of service, 36 months for 100% rate

POST 9/11 GI BILL CONTINUED

- ► There is a 15 year delimiting date if veteran came off of active duty before January 1, 2013
- ► There is no delimiting date if veteran came off active after January 1, 2013
- ► Veterans can transfer entitlement to their dependents if they are currently serving and have more than 6 years of service and less than 16 years
- ► Transferring entitlement obligates the service member to 4 more years of service

MONTGOMERY GI BILL SELECTED RESERVE

- ▶ Called the Reserve Gi Bill or Chapter 1606
- ▶ 36 Months of benefit
- ▶ Only pays a stipend to the veteran, no tuition
- ▶ Not transferable to dependents
- Service member can only use this benefit while they are actively drilling

DEPENDENTS EDUCATIONAL ASSISTANCE

- ► Called Chapter 35 or DEA
- ▶ Up to 36 months of benefit if they began using the DEA after August 1, 2018
- ▶ Paid to dependents of service members that are killed in action, 100% IU, 100% PT, etc
- Stipend paid directly to the student
- ▶ No tuition is paid to the school

OTHER EDUCATION BENEFITS

- ► FRY Scholarship
 - Available to dependents of those that died while on active duty
 - ▶ 36 months of benefit paid at the 100% Chpt. 33 rate
 - ► FRY beneficiaries are now eligible for yellow ribbon, new change!!

APP & OJT

- ▶ What is required?
 - ▶ Must be veteran on staff with company
 - ▶ Training must be entry level
 - Wages have to be set salary and cannot be commission based
 - ▶ Periodic wage increases are required
 - ▶ Direct Supervision of trainee is required
 - Must be full-time training and not less then 30 hours a week

APP & OJT

- ► Application Procedures for the Agency
 - Veteran is identified as wanting to use their benefit
 - Application needs to be filled out by the agency wishing to offer the GI bill to their employee
 - Training outline is reviewed by the SAA
 - Certifying officials is designated by the agency
 - Site Visit is conducted by the SAA
 - ▶ Appropriate forms are filled out by the agency in conjunction with the SAA (22-8864, 22-1999, 20-8206, 22-65<u>53d-1, 22-8794</u>)
 - Approval material reviewed by the SAA and approval is sent to agency and the VA

APP/OJT

- Application Procedures of the Claimant
 - Claimant wants to use their benefit
 - Claimant applies through https://www.va.gov/education/how-to-apply/ or https://www.ebenefits.va.gov/ebenefits/homepage
 - On application, claimant needs to provide name of agency they are working for, Direct Deposit info, which benefit they want to use
 - ▶ If they elect Chapter 33 they have to revoke Chapter 30, 1606 or 1607
 - ► Need to provide general description of work
 - Need to provide enlistment and separation dates
 - Need to provide current level of education
 - VA will send Certificate of Eligibility(COE)
 - Claimant give COE to their agency

IHL & NCD

- ▶ Institutes of Higher Learning
 - ▶ 2 year institutions
 - ▶ 4 year institutions
 - ▶ Tribal Colleges
- ► Non-College Degree Schools
 - ▶ Welding Schools
 - ► Cosmetology Schools
- ► Accredited vs Non-Accredited

IHL & NCD APPLICATION

- School submits Application to the SAA
- Programs reviewed by the North Dakota SAA
- Site visit conducted
- Certification process and expectations reviewed with the school
- Certifying Official is designated by the school
- Approval sent to the School and the US Department of Veterans Affairs
- VA accepts approval or rejects approval
- Student makes application
- School Certifies enrollment info to the VA
- ▶ Student gets paid

APPLICATION FOR IHL/NCD

- Same application process is used by VA claimants for all types of institutions
 - ▶ Online
 - **▶** 22-1990

APPLICATION FOR HIGH SCHOOL

- High Schools are considered Non-College Degree Schools
- ► Chapter 35 Dependents Educational Assistance can be used in High School
- School submits application with student handbook and schedule
- Certifying official is designated
- Application material is reviewed and approval sent
- ▶ Claimant is certified to the VA

WHAT CANNOT BE APPROVED

- Any program that does not lead to an vocational objective as determined by the SAA
- Programs that are considered AVOCATIONAL such as classes seeking to further interest in a particular hobby
- ► Continuing Education classes or programs
- ▶ Part 61 Flight training-Private Pilot training
