Governor's TaskForce – getting ready to give their report, then COVID appeared. Commissioner and Guard have very tight budgets and need to work together this Legislative Session. The Guard appreciates the support given from ACOVA and Legislative Council during last session. Bills concerning active duty that were passed have made a big difference. Guard update: getting troops back from missions, troops getting ready to deploy. COVID – Guard has been helping out at the State Laboratory, at least 60 guardsmen have been out there. Mobile testing sites have been run by the Guard, although they are looking for a civilian solution. Presently Guardsmen are being paid with federal funding, they need to be on for 31 days to get healthcare and education

benefits. They are on duty for 45 days to account for any quarantine time if someone tests positive.
