What makes us unique?



- Home atmosphere
- Private rooms and bathrooms
- Resident living specialist: Staff members in the household
- Recreational activities - including scenic drives, shopping trips, bingo, parties, dances, card games, trips downtown, plus much more.
- Primary care is offered on-site by a local provider

What makes us unique?

- Transportation to the Fargo VA Medical Center
- Support from Veteran Service Organizations
- Onsite Veteran Service Officer to assist with applications for VA benefits
- Psychiatrist visits
- Psychologist visits
- Physical, Occupational and Speech therapy services are contracted
- 24-hour nursing staff
- On-site pharmacy (for Veterans)



Criteria

To be eligible for admission, veterans must meet one of the following criteria:

- Bona Fide resident of North Dakota for 30 days
- Must have served in a North Dakota regiment
- Entered the Armed Services as a North Dakota resident: or
- Spouse or surviving spouse of above veteran

NDVH is unable to accept residents who are receiving dialysis treatment.

NDVH requires that applicants who have a diagnosis of alcohol or substance abuse have nine to twelve months of documented sobriety before being accepted to NDVH.

Applicants who apply for admission and are denied, are eligible to reapply after a period of 24 months unless otherwise stated in a denial letter.

The North Dakota Veterans Home defines Veterans under Century Code:

37-01-40. **Veteran and wartime veteran defined - Uniform service dates for wartime veterans.**

Checklist for Admissions

- Application for admission
- Certified Copy of Honorable Military papers/ DD214
- Completed 10-10SH along with a Chest X-ray Completed in the last 6 months.
- Durable Power of Attorney Papers/ Guardianship Papers/ Conservator papers
- Award Letters from the Veterans Affairs- verifying pension/compensation, disability etc.
- Copy of Social Security Card
- Copy of Current Driver's License or ID
- Copy of last Bank Statement, IRA's, Bonds, etc.
- Verification of income and assets
- Copies of Insurance cards, including Medicare and secondary insurance if applicable
- Copy of current vehicle insurance if applicable and bringing vehicle to NDVH
- Signed authorization for background check-or completed background check
- Signed medical releases of information
- Widower needs to submit veteran's death certificate

Cost

Basic Care:

Room and board charges for basic care are based on your monthly income less medical expenses. Each veteran is allowed to keep the first \$100 of income each month that will not be used in the rent calculation. Rent will be calculated at 55% of the net income amount arrived at by subtracting your allowable medical expenses from your income. There is a cap on rent that may vary yearly dependent upon the calculated cost of care. The current rent cap is \$1,543. Spouses of veterans pay the max rate regardless of income or expenses.

Other charges that may incur are:

- Haircuts
- Travel – Per VA eligibility
- Pharmacy-Per VA Co-Pay regulations
- Cable - \$9.00 must provide own television

-Residents of Basic Care need to be independent in ADL's.

Cost

Skilled Care:

Skilled care residents are charged a daily rate as developed by the State of North Dakota Human Services Case Mix System. The North Dakota Veterans Home completes an MDS assessment on each new admission within 14 days. This information is then transmitted to the State of North Dakota so a case mix level can be assigned. The case mix level determines the daily rate that will be charged.

The North Dakota Veterans Home pre-bills room and board charges at the lowest case mix level. Rent will be calculated using the lowest case mix level on the day of admission and payment will be due at that time. Once we have received the case mix level assigned from the State of North Dakota we will correct the billing and any additional charges will be due on the next bill.

Other charges that may incur are:
Pharmacy-Per VA Co-Pay regulations

- Service-Connected(SC) disability rating of 70 percent or more; OR
- Needs nursing home care for a SC disability; OR
- Rated 60 percent SC and is either unemployable or has an official rating of "permanently and totally disabled."
